Basic Telephone Service

Deposit of \$40 and a copy of picture ID are required prior to activation.

Residential line connection: \$7.60 Business line connection: \$14.00
Residential service order fee: \$13.00 Business service order fee: \$25.00

The basic monthly bill for residential service is *approximately* \$31.00 + tax.
The basic monthly bill for business service is *approximately* \$35.00 + tax.
This is billed from the date of activation to the end of the billing period and for the month ahead.
